


Performance Transmisson Cooler Bar and Plate

Installation Guide





CONTENTS

INSTALLATION

- Ensure the vehicle is off and cool. Disconnect the negative cable from both batteries.
- Disconnect the wiring harnesses for both sensors and remove any clips attached to the air box lid.
- Loosen the hose clamp that connects the intake tube to the air box lid, then remove the air box assembly.
- Disconnect all plastic clips then remove the radiator shroud. (Fig. 1)
- 5. Remove the bolts then remove the grille. **(Fig. 2)**






 If necessary, remove the bolts securing the A/C condenser and the air diverters on the sides to access the transmission lines. (Fig. 3)





- Disconnect the two transmission lines from the factory transmission cooler.
- Remove the two bolts securing the factory transmission cooler, then remove it from the vehicle.
- Check that the two Transmission Line Fittings (B) are securely installed on the Transmission Cooler (A), then install the transmission cooler. (Fig. 4 & 5)






 Reinstall the two factory bolts to secure the transmission cooler. (Fig. 6)





- 11. Reconnect the two factory transmission lines to the Transmission Cooler (A). (Fig. 7 & 8)
- 12. Reinstall any necessary components that were removed during installation.
