


Heavy-Duty Cast Aluminum Transmission Pan 68RFE

Installation Guide





CONTENTS:

- A. (1) 1/4" NPT plug (installed)
- B. (15) M6-1.0 x 25mm Socket Head Cap Screws
- C. (1) 1/8" NPT plug (installed)
- D. (15) M6 Flat Washers
- E. (1) One-inch Neodymium Magnet equipped Drain Plug (installed)
- F. (1) PPE Deep Transmission Pan (68RFE)



PREPARATION:

Step 1. Vehicle off. Engine cool.

Step 2. Remove stock pan bolts. Carefully drain fluid. Thoroughly clean mating surfaces.

INSTALLATION:

Step 3. Reuse the OEM rubber gasket if available, or apply high-temp silicone to the pan surface.




Step 4. Carefully mate surfaces together. Thread two M6 Washers and two M6 Screws on each side of the Pan. Finger-tight to secure.



Step 5. Install remaining M6 Flat Washers and M6 Screws. Tighten in crossing pattern as depicted in Fig 1.

Torque bolts 8-10 ft. lbs.



Step 6. Tighten NPT snug. Tighten drain plug to 18-22 ft lbs.

Step 7. Fill with manufacturer recommended transmission fluid.


Start engine. Check for leaks.

This completes the PPE Pan installation.

Refer to the manufacturer's recommendations for additional procedures relating to the transmission.
