

### trimmLINE by Cognito Leveling kit for 2001 to 2010 2/4WD Chevrolet/GMC truck 1500HD, 2500, 2500HD, 3500, 3500HD

and

# 2001 to 2012 2/4WD Chevrolet/GMC 2500 Suburban and 2500 YukonXL

#### **Introduction**

- Installation requires a qualified mechanic.
- Read instructions carefully and study the pictures (if included) before attempting installation.
- Check the parts and hardware packages against the parts list to assure that your kit is complete.
- Always wear safety glasses when using power tools.

## **\*\*\***Upon completion of the installation, headlight adjustment and front end alignment are required **\*\*\***

#### **Instruction Set** # 8105

#### **Installation Instructions**

- 1. Always work on a properly supported vehicle. Lift the front of the vehicle off of the ground by the frame so the front tires and suspension droop down.
- 2. starting on the passenger side, support underneath the lower control arm with a jack and raise the suspension slightly.
- 3. Remove the lower shock bolt from the factory lower shock mount bracket.
- 4. Then remove the 2 bolts holding the factory lower shock mount bracket to the lower control arm.
- 5. Discard the factory mount and replace with the supplied extended shock mount as shown in Figure 1, torque bolts to 50 ft-lbs.. Replace the shock to its new mount with the factory hardware previously removed, and torque to 65 ft-lbs. If you are using an aftermarket shock, you may not need to use the extended shock mounts depending on the length of the shock. Consult with Cognito Motorsports if needed.
- 6. repeat the previous steps on the driver side.

- 7. With both front wheels and front suspension drooped fully, remove torsion bar adjusting screws as shown in Figure 2.
- 8. Using a torsion bar tool, load torsion bar as shown in Figure 3, and remove adjuster nut as shown in Figure 4, then unload torsion bar and remove tool.

- 9. Slide torsion bar forward into lower control arm. If bar seems lodged, use a punch and hammer to loosen through the hole in the back of the torsion bar cross member. This will allow the adjuster to fall out. Repeat this to the other side.
- 10. Reinstall the new adjuster key in the reverse order.
- 11. Tighten the adjuster bolt while the truck is still off the ground.
- 12. Do not tighten the adjuster bolt to raise the height of the vehicle while the vehicle is on the ground and the front suspension is holding its own weight. This will cause the adjuster bolt excess stress and will most likely strip the threads.

- 13. Set the vehicle on the ground and back out the adjuster bolt to lower the vehicle to the desired ride height. You must drive the vehicle forward and backward a couple of times to allow the suspension to settle into place. Level the truck side to side by measuring from the top of the tire up to the lip of the fender well.
- 14. Do not set the ride height too high for the given application, adverse effects will occur. If using the stock upper control arm, there must be at least 1.5" of clearance between the bottom of the upper control arm and the frame perch down travel stop.
- 15. Raising the height of the vehicle will cause premature wear of the pitman and idler arms, therefore it is recommended to also install the Cognito Motorsports Pitman and Idler Arm Support System.
- 16. Using the factory upper control arms, you can also expect marginal alignment settings and accelerated wear of the upper ball joints because of the increased ball joint angle after raising the height of the front of the truck. For this reason it is also recommended to use the Cognito Upper control arm kit and either longer after market shocks, or the Cognito shock extension brackets.
- 17. re-adjust the headlights per owner's manual, and have the front end professionally aligned to factory specifications.
- 18. the vehicle will handle differently due to increased ride height, please take time to refamiliarize yourself with the handling characteristics of your modified vehicle.

Cognito Motorsports warrants, to the original retail purchaser, that its suspension products are free from defects in workmanship and material for as long as the purchaser owns the vehicle on which the product was originally installed. Cognito Motorsports does not warrant the product for finish, alterations, modifications, and/or original installation contrary to specifications of Cognito Motorsports. Cognito Motorsports suspension products are not designed nor intended to be installed on vehicles used in race applications or for racing purposes or for similar activities involving abnormal abuse other than the vehicle was originally designed to handle or endure. (A "RACE" is defined as any contest between two or more vehicles, and/or contest of one or more vehicle against the clock, whether or not such contest is for a prize.)

This warranty is for a one-time replacement of each Cognito Motorsports product and does not cover any part that Cognito Motorsports has previously replaced under this warranty. This warranty does not include coverage for police or taxi vehicles, race vehicles, or vehicles used for government or commercial purposes. Also excluded from this warrant are sales outside of the United States of America. Alterations to the finish of the parts including but not limited to painting, powder coating, plating, and/or welding will void all warranties. Cognito Motorsports obligation under this warranty is limited to the repair or replacement, at Cognito Motorsports option of the defective product. Any and all costs of removal, installation or re-installation, freight charges, incidental or consequential damages are expressly excluded from this warranty.

This warranty excludes the following items: bushings, bumpstops, tie-rod ends, limiting straps, and hiem joints. These parts are subject to wear and are not considered defective when worn. They are warranted for 60 days of purchase for defects in workmanship. Cognito Motorsports suspension components must be installed as a complete system. Any substitutions or exemptions of required components will immediately void the warranty. Some finish damage may happen to parts during shipping and is not covered under warranty. This warranty shall not apply to any product that had been subject to accident, negligence, alteration, abuse, or misuse. Cognito Motorsports does not warrant products not manufactured by Cognito Motorsports. Cognito Motorsports reserves the right to supersede, discontinue, or change the design, finish, part number and/or application of parts when deemed necessary by Cognito Motorsports without written notice, and in the sole and absolute discretion of Cognito Motorsports.

#### Warranty Claims

All warranty claims must be submitted through the original company of purchase. All claims must be shipped back to the original company of purchase with an approved RMA number listed as a reference on the shipping label and clearly printed on two opposing sides of the package(s); product in question must be inspected by Cognito Motorsports before replacement parts are shipped out.

#### **Return Policy**

Cognito Motorsports has a no refund return policy. Under special circumstances, returns might be accepted with prior written approval. All returned product will be shipped freight prepaid. Product returned is subject to a 25% restocking fee. No returns will be accepted after 30 days upon receipt of product.

#### **Product Consumer Safety and Warning**

The installation of this kit will modify the suspension of your vehicle and may cause it to handle significantly different than a factory equipped vehicle.
